FROM THE CHAIRMAN



Heritage Centre

The design of the proposed Heritage Centre has been completed by Rasheed Dauda, a member of the ExCo and an architect alongside Otunba Bolaji Falase who is also an architect. Both gentlemen co-chair the Heritage Centre Planning Committee of ICOBA Europe. We shared the drawings with ICOBA North America's equivalent committee in January 2024 and are awaiting their drawings. As at the end of 2024 there sadly has been no progress regarding this. We continue to remain open to working with ICOBANA and are developing contingencies should we have to go it alone.

Education Quality Masterplan

A flagship project of ICOBA Europe, this project has been running for seven years and is currently in Phase II which has as its objective the consolidation of gains made in Phase I. The Task Force established by the ExCo is led by our past Chairman, Dr Deji Okubadejo whose report is included in this Annual Report. In summary, it is going well and my thanks to the Task Force for their hard work and diligence.

Retirement and Valediction

A major milestone was the retirement of our highly esteemed chaplain, Revd Bunmi Fagbemi. This came as a shock as he has been a pillar and stalwart of ICOBA Europe. For so many years, Holy Trinity Tottenham, the Anglican church where he was vicar, has been the equivalent of the school chapel here in the UK. Both the church and the vicarage were central to the life of ICOBA here in Europe. Our familiarity was such that successive organists at the church could all play the school song! I cannot fail to mention the role of Mrs Toyin Fagbemi, the founding president of WICOBA, who looked after us and ensured we were watered and fed. I am only pleased that after a few years of resistance, Revd Fagbemi finally bowed to the pressure placed on him to attend the 2024 Founders' Day Awards ceremony of ICOBA International in Lagos to receive his merit award. I cannot think of anyone more deserving of the honour. The good news is that we will still have his leadership and expertise in his new role as a Trustee of ICOBA Europe which leads me nicely on to the subject of Trustees.

WICOBA Hosting, Sponsorship and Recognition



Reunion/Annual General Meeting 2024

The Secretariat facilitated the Reunion/Annual General Meeting (AGM) 2024 at held from Thursday 25 to Sunday 28 July.

EDUCATION QUALITY MASTERPLAN



The Education Quality Masterplan (EQM) remained the flagship project of ICOBA Europe in 2024. The aim of the project is to improve the quality of teaching and learning at Igbobi College Yaba, Lagos, Nigeria (ICY). The need for the project arose out of an assessment of the state of education at ICY which concluded that there was a need to build the college back to its position as a top education facility for boys delivering high quality education and preparing the future leaders of the progress with EQM. EQM-T

EQM was launched as a 2-phase project in August 2019 with the first phase being a rapid turnaround of the College and the second phase being an embedding of the gains from phase 1 into business as usual as well as ensuring ongoing quality improvement.

EQM is managed on behalf of ICOBA Europe by the EQM Task-Force (EQM-TF), the members of which are:

EQM-TF is responsible for the implementation of phase II of EQM and receives an ICY school report every term from the ICY leadership team. The task-force reviews the report and provides a formal feedback as well as a meeting with the senior leadership team of ICY which is held via a virtual online meeting platform. 2024 represented the third year of implementation of phase II of EQM and the school has continued to make good

progress with EQM. EQM-TF has also supported ongoing improvement in the quality of the school reports.

The school reports continue to show positive progress in terms of the processes that have been established at the college. As policies and processes have become robust, EQM-TF has challenged the school to move more towards outlining and measuring outcomes and achievements rather than just reporting on policies and processes. The school is now able to predict and measure students' progress and achievements, tracking these along their journey through the school. There is also a high level of engagement by the ICY academic staff in the continuous professional development programme (CPD) offered by the school. ICY team continue to arrange internal CPD on various relevant topics and they also engage with the external CPD offered through Transformational Teachers' Network (TTN) by Meadowhall Charity Foundation. The TTN offering is full funded by ICOBA Europe for all the teachers in the school

ICY now produces an annual School Development Plan as well as a dashboard that facilitates tracking of student and teacher performance as well as target setting in the school. The 2024 external examinations results with the West African Examinations Council (WAEC) were excellent with 100% pass rate in all the subjects taken and with 100% of the boys achieving grades A1 to C6 in every subject except English literature. Again, there was 88% to 100% distinction rate in every subject except English literature. Of particular note was the

very significant improvement in English language compared to the 2023 result.

ICY continues to provide a rounded education for the boys with emphasis beyond just good academic performance through the provision of targeted extracurricular activities. Notable among these were the 2024 Biannual Cultural Day celebration in January, a cultural day and excellent results from participation in science, debate, quiz and sports competitions. EQM represent a continuing commitment for ICOBA Europe which means that there is a requirement for ongoing funds and fundraising to support the project. The Association will appreciate dedication donations to support EQM.

OBIC UK has set out its strategy and plans and these can be viewed on the organisation website https://obicuk.org/ where its vision and mission are also outlined.

OBIC has identified key strategic intents which are complementary and mutually dependent. These are,

- Promoting engagement and academic achievement for black and mixed-ethnicity pupils in the UK
- Promoting a business entrepreneurial spirit for black and mixed-ethnicity pupils in the UK

Underlying these is a need for financial stability by attracting sufficient funding to promote and achieve these strategic objectives.

OBIC UK also aspires to function as a facilitating organisation by delivering training on related issues and also being a voice and playing a pivotal role

in influencing UK educational policy to be one of relevance to the needs of children from the black and ethnic minority communities. There is a need for work on the equality, diversity and inclusion agenda as well as a desire to influence the UK school curriculum. The company has approached a number of education organisations in southeast England in order to partner with them in the work to develop and motivate black children to aspire to greater heights. It is the intention that OBIC UK will also work with Igbobi College Yaba in Lagos, Nigeria as part of its charitable activities.

Our main event for 2024 was the AGM & Reunion weekend in July. Thanks to generous support from members and friends of ICOBA, the Heritage Centre Project Fund was boosted by £30,529 during the year. We are particularly grateful to WICOBA who undertook a walk to raise funds and challenged members of the Association's Executive Committee to match the funds they raised (I'm glad to report that ExCo rose to the challenge!). £60,626 had been

raised during our 90th Anniversary celebrations, bringing the total of the Heritage Centre Fund to £91,155.

Heritage Centre pledges totaling £8,187 remained unfulfilled as at 31 December 2024. At the time of writing, the unfulfilled balance has reduced to £4,309.

Efforts to recover the outstanding amounts are ongoing. Funds raised have been held in our interest-bearing account throughout the year, earning interest of £1,093 (2023 – £561), equivalent to approximately 11 annual subscriptions.

The Executive Committee has determined that the Heritage Centre donations should be ring-fenced, so the accounts for this year have been presented on that basis. Efforts are afoot to progress the Heritage Centre works on the College site as soon as possible.

We once again express gratitude for the continuing support of our members. There was a reduction in the number of subscribers compared to the previous year, however **47** members (2023 – **59**) remained diligent with their subscriptions during 2024. We continue to appeal to members to keep up with their subscriptions. A special call is made to Old Igbobians in Europe who have not yet boarded the subscription train to do so now. The full list of subscribers is included later in this report.

Income for the year was £64,149 (2023 – £22,275), the growth being a factor of fundraising activities in 2024. The surplus for 2024 was £21,879 (2023 – deficit £1,025). The Association's cash balance as at 31

December 2024 was £90,937 (2022 - £71,153).

Members are reminded that our flagship initiative — the Education Quality Masterplan (EQM) — is ongoing. We encourage members to continue with the financial support of EQM.

The Association's calendar included the ICOBA Europe Christmas Party for the first time this year. The memorandum account for the event is presented below:

For the year ended 31 December 2024

1 Accounting Policies

Basis of preparation

The accounts have been prepared under the historical cost convention.

Subscriptions

Subscriptions are accounted for in the period in which they are received, or where specified for subscriptions received after the balance sheet date, in the period they relate to.

Donations

Donations received for the general purpose of the Association are credited to Unrestricted Funds in the period in which they are received.

Depreciation

Tangible fixed assets are measured at cost less accumulative depreciation and any accumulative impairment losses. Depreciation is provided on all tangible fixed assets, other than freehold land, at rates calculated to write off the cost, less estimated residual value, of each asset evenly over its expected useful life, as follows:

Plant and machinery

25% straight line

Designated funds

Designated funds relate to amounts set aside for designated projects to benefit the college and are disbursed in accordance with the terms of the applicable restrictions.

Resources expended

Expenditure is accounted for on an accruals basis. Overhead and other costs not directly attributable to particular functional activity categories are apportioned over the relevant categories on the basis of the committee's estimates of the amount attributable to that activity in the period as appropriate.

Reserves

The Association's objective is to build its reserves, in the form of unrestricted funds, to a level where they equate in value to approximately twelve months direct expenditure, thereby providing the Association with a reasonably secure financial base on which to plan future projects and to commit to related expenditures, before external funding has been fully secured.
